Private School Requirements

- Declare non-profit status
- Consult with district personnel regarding service options
- Complete a written affirmation for the district accepting or denying services
- Follow applicable federal requirements
- Document the number of students and/or teachers receiving services and a description of the services provided.

Nonprofit Status...

 Declare nonprofit status by telephoning the IRS at 1-800-829-1040 and requesting package 1023

• Form 501

- Federal requirements...
 Services/benefits will be secular, neutral, and nonideological
 - Services must supplement and not supplant available services in private nonprofit schools.
 - Services will used to meet the special educational needs of the students, not the general educational needs or the school.
 - MISD must keep title and exercise continuing administrative control of all property, equipment, and supplies that is used in the private schools.
 - Nondiscrimination required
 - Participating private schools may receive services only. They may not receive funds.

Size and Scope of Equitable Services

- Determine the number of children from lowincome families in private schools
- What data is needed to identify children's needs?
- What services are needed/how children will receive these services ?
- What campus staff will provide these services ?
- How the services will be assessed and how the results will be used to improve services?

Title I Part A Expenditures continued

- District-wide professional development to include consultant coaching opportunities at the campus level and DMAC ESC 7.
- Parent Involvement and Support
 - Athens Help Center: Serves as a liaison for district to support students identified under the McKinney-Vento Act, students at risk due to drugs, students with situational depression, provide campus based trainings, support students and parents at the DAEP.

Title II, Part A – Teacher/Principal Training/Recruiting (\$125,000 with \$12,616 going to Region 10 ESC)

- *Purpose*: to increase academic achievement through improving teachers and principal quality and increasing the number of highly qualified teachers/principals in schools
- Also part of the class size reduction program to decrease student/teacher ratio in classrooms
- Develop and deliver on campus research based professional development and mentor new teachers
- Develop and deliver TEKS aligned curriculum & common assessments
- Data analysis of common assessments & develop plans to respond appropriately to data.

Title II A funds are used to provide intervention specialists at the three elementary campuses. (75% Title II A and 25% Title I Part A)

Title I, Part C – Migrant Students

- Purpose: to provide supplemental services that meet the special educational needs of migrant children ad coordinate local migrant educational projects
- Aid in identification, acquisition of equipment and instructional materials, support services such as health, counseling, and nutrition
- Coordination of services between Region 10 and district to help migrant students perform in an educational setting.

Funds provided through Title I, Part C go directly to Region 10 ESC to oversee any applicable Title I recruitment or provision of services.

Title III Language Instruction for ESL

 Approximately \$7,500 in personnel costs to fund ESL paraprofessional position at the elementary level.
 Region 10 ESC receives a percent of the total allotment to support Mabank ISD in providing teacher professional development.

- 2. Mr. Pate completed application and was awarded the TEA Technology Lending Grant for approximately \$100,000. These funds will be utilized to continue the roll out of one-to-one devices at Mabank High School. Next school year, MHS should be one-to-one at 9th, 10th and 11th grade.
